## TEKKATHO FOUNDATION: AT A GLANCE

### WHAT WE DO

The Foundation uses digital technologies to support educational change across Myanmar. We build and deliver free, self-contained digital libraries of educational resources that the current generation of students and school children can use right away.

Our Tekkatho MyLibraries are designed for teachers and learners in Myanmar and work even in places with no internet or phone signal. Each MyLibrary capsule is packed with thousands of exciting educational resources, the best of the web adapted for offline environments. These include the Myanmar national curriculum materials as well as complete teacher training courses, video lessons, interactive games, and practical vocational training resources on agriculture, entrepreneurship, construction, healthcare, workplace and digital skills.

***Our mission is to advance the education, particularly but not exclusively, of the people of Myanmar (Burma), including by:***

- (a) providing digital libraries and other education infrastructure in areas of limited or no internet connectivity;***
- (b) promoting exchanges, teaching placements and research partnerships between educational institutions and international partners.***

Our local hosting model means that people can dependably access the eTekkatho library content at high speed from within the school or library building even when connectivity is poor. In this way, we provide young people with fast and easy access to a wealth of learning opportunities in schools, colleges, community libraries and refugee camps across Myanmar.

Today's students, who will play such a key role in the economic, social and political future of Myanmar, often struggle to gain a relevant education in institutions that lack the tools they need to deliver a strong learning environment. Our projects deliver quick, effective solutions to this problem.

We believe that improved access to resources in education will transform minds and opportunities, powering society and enabling more fulfilling lives. We aim to strengthen education across the whole country so young people can benefit from the opportunities digital technologies bring wherever they study and whatever the political future may hold.



## TRUSTEES REPORT: IMPACT & ACTIVITIES

*For the year ended 30 September 2023*

### KEEPING THE DOOR OF EDUCATION OPEN

The military coup of February 2021 has had profound and devastating effects on the ordinary people of Myanmar. The military's nationwide crackdown on dissent has intensified the conflict, spreading fighting between the military and armed opposition groups across most of the country. The UN estimates the number of people in humanitarian need has risen to 18.6 million, with the education and health systems near collapse. More than 1.8 million people have been displaced from their homes because of the coup.

Myanmar's youth and children are bearing the brunt of this crisis. Conflict, displacement and economic hardships have severely disrupted education. According to recent reports, barely a fifth of eligible students are now enrolled at high-school level and hundreds of schools have been destroyed in the conflict. With the state education system in crisis, and a generation of children at risk of losing their education, new community-led education initiatives are urgently needed.

The immediate response of the Tekkatho Foundation was to set up new learning spaces and strengthen teacher training initiatives in the border regions to keep the door of education open.

## TRAINING NEW TEACHERS, BUILDING LIFE SKILLS FOR VOCATIONAL LEARNERS

We have been working with Monde par la Main (Give a Hand) to improve educational opportunities for young people living in border states. Under the Virtual Classrooms Myanmar project, we implemented learning hubs in off-grid communities in Kachin State and Kayin State. At the heart of the hub is the MyLibrary, a self-contained, portable digital library that works without the need for an internet connection packed with thousands of educational resources for students of all ages.

In Kachin, we implemented the MyLibrary at Ningshawng Social Institute (NSi), in Palana, Kachin State. NSi provides further education to the local community, many of whom are refugees (Internally Displaced People) fleeing conflict elsewhere in Myanmar. The institute runs an active teacher training programme and vocational training courses. The MyLibrary at NSi contains teacher training resources, plus hundreds of vocational training resources on agriculture, entrepreneurship, healthcare, workplace and digital skills.

There is an urgent need to train new teachers to work in refugee camps, community centres and non-formal schools. Every MyLibrary contains the fantastic bilingual Yaung Zin Competency-Based Teacher Training Programme, designed to promote child centred learning at primary level. For older students, MyLibrary provides the Mote Oo teacher training materials on lesson planning, assessment and classroom management in secondary education. Additionally, MyLibrary hosts teacher training resources for post-secondary schools and adult education programmes from Thabyay Education Network's Curriculum Project. These resources are specifically designed for teacher training in learning centres run by and for refugees, migrant workers and other marginalised groups.

NSi offers existing community teachers the opportunity to build their professional development skills, and an 8-month Diploma in Teacher Education for new teachers. In the reporting year, 51 teachers from primary, secondary, and high schools across Kachin—including Myitkyina, Laiza, Mai Ja Yang, Bhamo, Putao, Hpakan, Danai, Waimaw, and Sadung—participated in the continuing professional development program. Additionally, 24 new teachers graduated from the Diploma in Teacher Education program. As part of our work to support the development of non-government adult education initiatives in border regions, the Tekkatho Foundation provides the MyLibrary and weekly training sessions.

Ma Khon Mai, our Education Officer in Kachin runs training courses and reading challenges as part of the NSi core programmes. Since the start of the Virtual Classrooms Myanmar project, almost 2,000 people from all over Kachin have taken part in regular training, learning English, science, teacher training and business management, or just reading for fun with the Tekkatho MyLibrary.

## EDUCATION EVERYWHERE

In Kayin, we set up a MyLibrary at Maw Paw Khoet community centre in the Dawna Hills. The centre acts as an educational hub for the surrounding villages, supporting around 400 primary and secondary school children in their education. The people here are majority Karen with a large migratory community.

Our Education Coordinator in Kayin, Zayar Aung, set up a reading program at the centre and took the MyLibrary on tour to local schools. He reported that the most popular resources are the British Council resources for learning English, and the physics, chemistry and mathematics videos from Khan Academy. Younger children love the local language storybooks from Third Story Project.

In early 2023, escalating conflict in the region made it too dangerous for Zayar Aung to travel from Hpa-an to the centre in person. We are very grateful to Teacher Poe from Maw Paw Khoet for stepping in to run the learning hub and extend its reach even further through school visits and discussions groups.

Teacher Poe reports that *“students have been worried and challenged about their current education during uncertain times, especially between high school and foundation level, and value the extended extra curriculum to go for their future.”*

Additionally, around 200 adult learners use the library each month for independent study.

## FUTURE LIBRARIES

In September 2023, we launched two new initiatives. Raise a Hand is a new project funded by Monde par la Main which will set up new eLibraries at two off-grid locations in rural Kachin. Ready to Learn will build on the 2021 pilot scheme in Chin State with an expanded learning centre in Cikha and a new learning hub in Putao.

## TRIBUTE TO PAUL MURPHY (1980- 2023)

Our friend, co-founder and trustee Paul Murphy passed away in March 2023. Paul was passionate about science, loved technology and believed in the transforming power of education as a passport to dignity and independence of thought. He will be very much missed.

Paul joined the University of Manchester in 2008, where he teamed up with Celia Russell and Yin Min Tun to start the first eTekkatho project. Paul developed the original technologies that powered eTekkatho and founded the Tekkatho Foundation in 2013. He travelled across Myanmar the same year, setting up our very first digital libraries at Mandalay University, Yangon University, Dagon University, Myitkyina University, UDE in Yangon and the Myanmar Environment Institute.



In 2012 Paul joined Co-operatives UK where he was Head of Digital for the next eight years, a hugely valued and popular member of Co-operatives UK's Management Team. In 2014, our new Head of IT, May Thet Khine Nyein joined Paul in Manchester for her initial training. In 2020, he moved on again to pursue a PhD in AI, Machine Learning and Advanced Computing at Cardiff University.

Throughout all this time, Paul was an active Tekkatho Foundation Trustee, joining the regular weekly team meetings and leading on the technical strategy and governance of the Foundation. He returned to Myanmar over the years, setting up new libraries in Chin State, Kayin State, Shan State and Kayah State. He was part of every decision, and thanks to Paul's inventiveness and determination, there are Tekkatho libraries in every state and region of Myanmar.

Paul died on March 19 2023 aged 42, after being diagnosed with lymphoma in 2021. He had joined his last Tekkatho team meeting just a few weeks before. With his usual diligence and care, Paul took steps to hand over his role to ensure the work of the Tekkatho Foundation will continue.

Ten years ago, Paul drafted our guiding mission to improve access to education in Myanmar, irrespective of where people live, their ethnicity or faith. We remain committed to his principles of keeping the door of education open to all.



# FINANCIAL REPORT: NOTES TO THE FINANCIAL STATEMENTS

*For the year ended 30 September 2023*

## 1. ACCOUNTING POLICIES

The principal accounting policies adopted, judgments and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

### **BASIS OF PREPARATION**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), second edition - October 2019 (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006 and UK Generally Accepted Accounting Practice.

Tekkatho Foundation meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

### **PREPARATION OF THE ACCOUNTS ON A GOING CONCERN BASIS**

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern. The trustees have made no key judgments which have a significant effect on the accounts.

The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

### **RESERVES**

The charity aims to hold 3-months of operational expenditure in reserve. We consider reserves to be that part of our income funds that are freely available for operating purposes not subject to commitments, planned expenditure and spending limits. We do not include endowment funds, restricted funds or designated funds in our reserves.



## **INCOME**

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material. Income received in advance of a provision of a specified service is deferred until the criteria for income recognition are met.

## **DONATED SERVICES AND FACILITIES**

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised; refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

## **INTEREST RECEIVABLE**

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

## **FUND ACCOUNTING**

Unrestricted funds are available to spend on activities that further any of the purposes of charity. Designated funds are unrestricted funds of the charity which the trustees have decided at their discretion to set aside to use for a specific purpose. Restricted funds are donations which the donor has specified are to be solely used for particular areas of the charity's work or for specific projects being undertaken by the charity.

## **EXPENDITURE AND IRRECOVERABLE VAT**

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

Expenditure is classified under the following activity headings:

- Expenditure on charitable activities includes the costs undertaken to further the purposes of the charity and their associated support costs.
- Other expenditure represents those items not falling into any other heading.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

## **TANGIBLE FIXED ASSETS**

Individual fixed assets are capitalised at cost and are depreciated over their estimated useful economic lives.

## **DEBTORS**

Trade and other debtors are recognised at the settlement amount due after any trade discount offered.

Prepayments are valued at the amount prepaid net of any trade discounts due.

## **CASH AT BANK AND IN HAND**

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

## **CREDITORS AND PROVISIONS**

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

## FINANCIAL INSTRUMENTS

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

## FOREIGN CURRENCIES

Transactions entered into in currencies other than sterling are included in the accounts after conversion at the bank rate in force on the date.

## 2. LEGAL STATUS OF THE CHARITY

The charity is a company limited by guarantee registered in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity. The registered office address is disclosed on [page 11](#).

Sir Halley Stewart	Issued by Sir Halley Stewart Trust. Initially a one year grant running 1 October 2021 to 30 Sept 2022 of £5000 for Ready to Learn pilot project. Second grant awarded for two-year project running 18 Sept 2023 to 17 Sept 2025 of £40,000 for the main Ready to Learn project.
Monde Par La Main	Monde par la Main (Give a Hand) fund two projects. The first project, Virtual Classrooms Myanmar, was funded for Jan 2022-Dec 2022 with a grant of CAD\$16,000. This was renewed at CAD\$7,000 for Jan 2023 to Dec 2023. The second project, Raise a Hand, is a one year project starting 18 Sept 2023. The budget for Raise a Hand is CAD\$25,000.
