TEKKATHO FOUNDATION AT A GLANCE

WHAT WE DO

The Foundation uses digital technologies to support educational change across Myanmar. We build free, self-contained digital libraries of educational resources that the current generation of students can use right away.

Our local hosting model means that people can dependably access the eTekkatho library content at high speed from within the library building even when connectivity is poor. In this way, we provide young people with fast and easy access to a wealth of learning opportunities.

Our mission is to advance the education, particularly but not exclusively, of the people of Myanmar (Burma), including by:

(a) providing digital libraries and other education infrastructure in areas of limited or no internet connectivity;

(b) promoting exchanges, teaching placements and research partnerships between educational institutions and international partners.

We also run programmes of face-to-face training to introduce librarians and students to the availability and content of digital resources and build their IT and information literacy skills.

Today's students, who will play such a key role in the economic, social and political future of Myanmar, often struggle to gain a relevant education in institutions that lack the tools they need to deliver a strong learning environment. Our projects deliver quick, effective solutions to this problem.

We believe that improved access to resources in education will transform minds and opportunities, powering society and enabling more fulfilling lives. eTekkatho can be a driver of change right across Myanmar. We aim to strengthen university and medical libraries across the whole country so young people can benefit from the opportunities digital technologies bring wherever they study.

ETEKKATHO AT MINGUN SCHOOL



2018 saw the launch of our MyLibrary digital library capsules. MyLibrary capsules are affordable, tough, portable, ready-to-go digital libraries built especially for use in Myanmar.

Each capsule stores thousands of educational resources and makes them available even in places with no internet connection or reliable electricity. It is battery powered and can be recharged via a portable solar panel.

First to try out this pioneering new technology were the children of a village school in Sagaing Region, run by Monk Owen, who comments:

"Education is the bridge to connect with the world. In this rural area, our children have limited access to education and modern teaching materials. This offline learning system is a big step to connect us to the world."

ETEKKATHO IN HIGHER EDUCATION

Universities too use eTekkatho to strengthen their teaching and research, as librarian Daw Yin Yin Aye of Dawei University explains:

"eTekkatho is essential to our Dawei University Library. It provides resources to multiple users without the need of internet connection, with no limits. The user interface is very simple and easy to use. Khan Academy Videos, Fuse School videos and other Special Collections are very useful. The subject specific videos from eTekkatho digital library are helpful for the students and faculty members."

At Yangon University, over 9,000 students use eTekkatho in their study. Dr Hlaing Hlaing Gyi, librarian says:

"We received eTekkatho Digital Library in 2013. Since then, the students and faculty members of Yangon University has benefited so much from using eTekkatho. The contents in eTekkatho are what we need, particularly, MIT Open Courseware, Khan Academy, My Learning Essentials and British Council. Students and Faculty members use these during their assignments and curriculum planning. eTekkatho is also used in Research. All these contents are freely accessible and don't rely on the internet for accessibility, I highly recommend eTekkatho for students and faculty members and I believe this will foster their learning."

In the reporting year, over 600k individual full text ebooks, video lessons, datasets, lectures and other types of educational materials have been downloaded from the eTekkatho eLibrary.

Some of our most popular resources included:

- Massachusetts Institute of Technology OpenCourseWare, containing video lectures, readings, exercises and exams for over 2,000 undergraduate and postgraduate courses
- Coursera MOOCs (self-contained courses) from the University of Manchester, complete with video lectures, quizzes and even a virtual laboratory
- Snapshots of Wikipedia, English and Myanmar language editions
- Fun science videos from Fuse School
- Khan Academy video lessons, many with embedded Myanmar subtitles
- English language learning materials from the British Council.

During the reporting period, we are pleased to report that, with the support from Omidyar Network, we have restuctured the eTekkatho programme to make it more scalable.

The Foundation began field testing its new MyLibrary technology for the delivery of digital library contents. MyLibrary capsules are affordable, tough, portable, ready-to-go digital libraries built especially for use in Myanmar. Each capsule stores thousands of educational resources and makes them available even in places with no internet connection or reliable electricity. It is battery powered and can be recharged via a portable solar panel.

The MyLibrary project has been designed to enable us to scale our programmes to hundreds of new locations and even harder to reach places, such as IDP camps. We plan to begin full scale rollout of MyLibrary technology in early 2019.

We have also transferred operational activities from the UK to Myanmar. The combined effect is that the cost of delivering a new library has been reduced by approximately 80%.

We have ensured that students as well as staff are able to access eTekkatho at all the university partners. This means that students and academics from a total of 31 universities are now able to access the eTekkatho digital library from their campus. Members of the public can access eTekkatho at a further 6 community libraries.

OUTREACH

With the support of Omidyar Network, we have run over 50 training courses during the reporting year, directly reaching thousands of learners, educators and librarians at eTekkatho partner institutions.

1. ACCOUNTING POLICIES

BASIS OF PREPARING THE FINANCIAL STATEMENTS

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The presentation currency of the financial statements is the Pound Sterling (£).

INCOME

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

EXPENDITURE

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

TANGIBLE FIXED ASSETS

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.
